Respectfully, This association wants to draw your kind attention about the repeated gross injustice done by MOIAB with the Engineering Assistant (herein after written as EA) in the Subordinate Engineering Cadre working in MOIAB.

2. We want to bring your kind notice that in compliance to the Hon'ble Supreme Court order, Govt. of India had granted the pay scale of Rs. 2000-3200 to EA through MOI&B order 310/15/93-B(D) dt. 15.05.1995.

3. Kindly take the cognizance of the DOP&T question (asked on the direction of Hon'ble Cabinet Secretariat) through letter dt. 25.01.2019 (**Enclosure 01**), about the implementation of the Hon'ble Cabinet UOI decision dt. 06.11.1997 w.r.t. EA cadre of MOI&B.

4. MOI&B) had replied (**Enclosure 02**) that the Hon'ble Cabinet UOI decision dt. 06.11.1997 had been implemented vide MOIAB OM dtd. 25.02.1999. (P 15-19; Enclosure 05)

5. It is our request to kindly revisit the MOIB OM dt. 25.02.1999 (**Enclosure 05**) w.r.t. Hon'ble Cabinet UOI decision dt. 06.11.1997 (**Enclosure 03**). The MOIB OM dt. 25.02.1999 reflects that,

(a) MOIAB has granted Rs. 6500-10500 Pay Scale (i.e. replacement Scale of Rs. 2000-3200 of 4th CPC) from 01.01.1996 as "**Upgraded Scale**",

(b) while the implementation schedule attached with the agenda note clearly state the Hon'ble Cabinet direction was to "**Protect the Pay Scale**" of EA, as 2000-3200 (IV CPC), in the honour of Hon'ble Supreme Court judgement in the case of Rajshekharan Vs. UOI.

6. Kindly see the another development of Restoration of Pay Scale of Sound Recordists of DDn whose parity was extended to EA by MOIAB order No. 310/15/93-B(D) dt. 15.05.1995.

DG:DDn through office Order No.13/2001-SI(A) from File No. 37/2/99-SI(A) dt. 16th April 2001, and with the Approval of the Ministry of Finance, Department of Expenditure (Implementation cell) vide their U.O. No. 6/59/2000-IC dt. 8.1.2001 and also with the concurrence of IFD of Ministry of I&B vide their Dy. No. 250/Fin. I, dt. 27.3.2001, "**protected the Pay Scale**" of incumbent Sound Recordists on personal basis (entire cadre) and allowed the replacement Scale of Rs. 6500-10500 to Sound Recordists from 01.01.1996. (P 20; Enclosure 06)

Hence, in light of reply given to DOP&T, through MOIAB letter No. 503/05/2014-BAE dt. 07.06.2019, it is the humble request to your kind office to kindly issue the corrigendum of OM 25.02.1999 for The "**Protection of Pay Scale (Rs. 2000-3200)**" and its Replacement Scale of Rs. 6500-10500 from 01.01.1996 onward in honor of Hon'ble Cabinet decision dt. 06.11.1997 w.r.t. Engineering Assistant, in true letter and spirit at par with Sound Recordists of Doordarshan to deliver the justice in full. This will cost no burden on the exchequer as all the Engineering Assistants are getting Rs. 6500-10500 from 01.01.1996.
