With due respect 'on behalf of our oldest association of All India Radio and Doordarshan i.e AIR & DD Technical Employees Association (ADTEA). We are very much thankful to you for granting us time for personal hearing. We are submitting following long pending issues for your kind consideration: -

1. Renewal of Recognition of our Association, which has been kept in abeyance since April, 2017, in the name of re-verification along with all 10 Associations Recognized as per RSA Act. Detailed representation dated 03/02/2020 is enclosed.
2. Issuance of corrigendum letter in R/o the pay scale of Engineering Assistant (E.A) according to the cabinet decision of Govt. of India dated 06/11/1997 and accordingly implementation schedule issued by the Joint Secretary, DOP&T, Govt. of India (normal replacement scale w.e.f 01/01/1996 in the pay scale of 6500-10500 replacement scale of 2000-3200) and not upgraded scale. Which was also recommended by the Ministry of I&B at that time i.e 1997. Detailed representation dated 27/08/2019 is enclosed.
3. Merger of Tech/Senior tech cadre as per the recommendations of Prasar Bharati/DG:AIR as Junior Broadcast Engineer. It is requested to kindly issue the Merger notification at the earliest.
4. Notification of recruitment rules for Helpers as recommended by Prasar Bharati and as directed by the Honorable CAT Principal Bench, New Delhi.
