 - 7. Zonal Publicity Secretary
- c) STATE SECRETARY POSTS: For each state in each Zone.

Essential Conditions for Nomination for Central Posts:

- 1) Contestants for National Organising Secretary Post and National Treasurer post should be posted at any office of AIR & DD at DELHI at the time of filing nomination.
- Contestants for the rest of the posts in the Central Body may or may not be posted any office of AIR & DD at DELHI at the time of nomination for election.

Essential Conditions for Nomination for Zonal Posts:

Contestants for Posts in Zonal Body shall be posted in any office of AIR & DD in their respective Zone at the time of filing nomination.

Essential Conditions for Nomination for State Secretary Posts :-

Contestants for State Secretary Post should be posted in the Capital Station of AIR & DD in their respective States at the time of filing nomination.

Rest of the conditions would be the same as mentioned in the Constitution of "AIR & DD Technical Employees Association".
