Subject:- Eligibility list of Assistant Engineers as on 01.01.2021 – regarding inclusion of their names in the eligibility list.

I have been directed to say that the preparation of Eligibility List for promotion of AEs to the post of JTS as on 01.01.2021 is under process. As per IB(E)S Recruitment Rules 2013, two years of service as AE is required for being eligible for consideration for promotion to JTS of IB(E)S in addition to possession of requisite academic qualification.

2. It is to inform that 451 SEAs were promoted to the grade of Assistant Engineer vide DG:AIR Order Nos. 9/2018-S.IV(B) and 10/2018-S.IV(B) dated 30.11.2018. These newly promoted Assistant Engineers will complete two years of service as AE in November/December 2020. The qualification details in respect of these newly promoted AEs needs to be collected for their inclusion in Eligibility List of Assistant Engineers as on 01.01.2021, if found eligible.
