Sub: Supervision and monitoring of re-verification of 10 associations already recognized by Ministry of I&B on 06.03.2013 as well as considering fresh application submitted by another group of employees who wishes to be recognized under CCS (RSA) Rules, 1993.

Reference this Secretariat letter of even No. dated 06.10.2017 regarding re-verification of membership of 10 associations earlier recognized by Ministry of I&B on 06.03.2013 as well as considering fresh application submitted by another group of employees who wishes to be recognized under CCS (RSA) Rules, 1993.

2. Aforesaid course of action should be processed in a time-bound manner and complete within six months. Accordingly, a time-frame has been decided for strict compliance of DoP&T instructions issued vide O.M. No. 2/13/98-JCA dated 24.05.2001 on the same which is tabulated as under:

Sr. No.	Process of recognition	Time for completion of the process
1.	To issue instructions seeking fresh application for recognition	Within 2 months from issue of the letter
2.	Defining fresh Distinct Categories of employees , if any as per DoP&T O.M. No. 3/12/94-JCA dated 10.03.1995. In this regard, a copy of the existing Distinct category of employees enclosed.	Within 5 days from expiry of two months of initial period of time seeking fresh application.
3.	Notifying with wide circulation viz official website, notice board in official premises etc. , for the information of employees the names of the associations (Fresh associations/ already recognized associations) and their Genral Secretary/ President who , prima facie, fulfil all the condition of recognition.	Within 5 days After Defining Distinct Categories.
4.	To issue instructions to all DDOs of Stations/Kendras of AIR and Doordarshan for decuction of subscriptions from members of associations (already recognized as well as fresh association) in the month of January, 2018 , who wishes to be members of an association(Here it is pointed that an employees will be member of only one association.). This may be done through Check-off system as per DoP&T O.M. No. 2/10/80-JCA dated 31.01.1994.	Within 10 days After notifying names of associations, with wide cirulation.

5.	Examination of fresh application viz. Bye-laws, memorandum of Association as per DoP&T O.M. No. 2/5/94- JCA dated 28.07.1994 etc. issued from DoP&T from time to time, writing to the association who have applied for recognition to re-submit within 5 working days the amended Constitution as per observation , if any.	Within 20 days After expiry of two months of initial period of time seeking fresh application, simultaniouly with process under Sr. No. (2), (3) and (4).
6	Compilation of details of membership DDO or any other designated authority-wise of stations/Kendra/LPTs/HPT etc of AIR and Doordarshan. Fowarding of proposal of both fresh association as well as already recognized association to Prasar Bharati	In the month February, 2018

3. For supervision and monitoring the entire process for timely completion of action in the prescribed time frame , it has been decided to nominate two Nodal Officers in the respective Directorate as under:
