Kindly take the reference of the action taken by audit team in DDK Lucknow (Copy enclosed 01). It is most unfortunate that despite Status Quo orders of various Hon'ble Courts, Department is not paying any heed towards the grievances of Subordinate Engineering Employees salary matter due to the wrong feeding by administrative wing .

We would like to bring your notice that

- (i) In OA 00932/2017, Hon'ble CAT Jabalpur Bench has granted the *Status Quo* order in respect to fixation of Pay as well as recovery qua the applicants until further orders. (Annexure-02)

- (ii) In OA 2655/2018, Hon'ble PB CAT Delhi has granted *Status Quo order* in respect to re-fixation of Pay as well as recovery. (Annexure-03)

Moreover, as per the order of Min. of Finance (Annexure-04), with consultation of DOP&T, it has been clarified that MACP cannot be granted retrospectively. Therefore, the Pay revision granted by MOIB, by executive order dated 25.02.1999, cannot be adjusted against any MACP because as on 25.02.1999 neither ACP nor MACP was in force.

Since, the matter is sub-judice, hence you are requested to desist such recovery steps countrywide immediately. If department fails to issue directions, it will be the dishonor of court of Law and department may attract the contempt of Court.

This association will be forced to go for agitation, for which decision will be taken on 10.02.2019.


We hope that Department will take the positive decision in this regard.
