With warm regards, we want to bring your kind attention that by the office order No.: 8/20/2015-S-IV(A) dated 12.05.2017, DG AIR has extended the pay scale of Rs.5000 – 8000 (as per 5<sup>th</sup> CPC) to those technicians, who joined before 25/02/1999, with the approval of nodal Ministries.

By the clarification issued through File No. : 14/44/2017-S-IV(A)/494 dated 04/08 /2017, for point no. 03, DG AIR had clarified **that Rs. 5000-8000 scale thus granted to Tech. is not the upgraded scale.**
